Upon careful reflection, I realize that I made critical errors of interpretation in my writings and lectures on a range of topics related to fundamental areas of essential doctrine such as the Imamate of our Twelfth Imam (A.S.). I further appreciate that these oversights and errors deeply hurt and affected core beliefs held by a community of believers who entrusted me to guide and reinforce their faith. To those fellow believers that I hurt or upset in any manner: I offer my deepest apologies for the pain and distress I caused.

My lifelong attempt to balance the "rational and objective" standards of modern secular academia while adhering to the responsibilities and standards of my 'aqeeda were, in a few but significant instances, a failure. As academia is prone to arrogance and airs of intellectual superiority, it was my responsibility to you as my fellow believers to continuously challenge my academic methodologies and conclusions from the lens of my faith and my community. I sometimes failed to do so, and this is something I deeply regret. As I now approach the end of my life's journey and examine the legacy I leave behind; I seek forgiveness from both Allah (S.W.A.) and from my community for any academic works and lectures that may have you distress and confusion.

Finally: I feel compelled to reiterate and reaffirm that I continue to hold the institution of *Marji'iyyat* in the highest esteem. As for the Ayatollah Sayyid Ali Husaini Al-Sistani, if I have in any way spoken or written things that appeared to undermine this great institution and his personality, again, I offer my absolute and sincere apologies.

I want to meet my Lord at peace with the intercession of my Twelve Imams and intercession of my Lady Fatima al-Zahra (S.A.).

Allah (S.W.A.) is the most forgiving, most merciful.
