#### **Terms and Conditions**

These are The World Federation of KSIMC (TWF)'s Terms and Conditions. TWF is a facilitator and organiser for this event. All participants must comply with TWF's terms and conditions in order to take part.

#### **Risk Statement**

TWF shall not be liable for any injury, illness or death of any person resulting from the participant's negligence. TWF shall not be liable for any loss or damage to property or any indirect or consequential loss however arising.

## **Payment of fees**

Registration for the tour is confirmed (if the conditions of participation are met) on receipt of tour fees which can be paid until 30th November to avail the early bird offer .i.e. USD 999, after which the tour cost will be USD 1199.

## **Conditions of Participation**

To take part in this tour participants must:

- be a member of a registered khoja ishna-asheri jamaat
- have two Covid vaccinations as a condition of participation as required by the law of the land
- apply for any relevant visas or any other travel documentation, at their own expense;
- complete and submit the tour application form;
- have adequate travel insurance; which must cover emergency search and rescue and medical expenses. We advise participants to take out cancellation insurance.

## Participant's Responsibilities

- Please consult your GP for anti-malarial and travel vaccine
- Participants will submit a scanned copy of their passport and proof of 2 doses of Covid vaccination.
- In terms of refused passage and/or entry/exit to or from any of the countries, any additional costs incurred are the participant's responsibility.
- if a participant does anything to void their insurance, including not declaring a pre-existing medical condition, they are fully responsible for paying any and all associated costs including travel and accommodation to and from the departure/arrival point in the India.

- Participants must observe modest clothing as prescribed by the Sharia during the tour
- Should the participant have to withdraw at any time, they will need to inform TWF by email. No refunds will be provided as most bookings are non-refundable.
- Baggage and personal effects are at owner's risk throughout the tour. Luggage weight restrictions will be provided in your itinerary.

#### **General**

- The cost of tour includes only the ground package, the rest needs to be borne by the participant himself.
- TWF has the right to subcontract any of its services to any third party service providers at its sole discretion.
- The participant understands and accept that itineraries, schedules and accommodation may change and other alterations may occur which are beyond the control of TWF or any supporting service provider.
- TWF reserves the right to increase the price of travel arrangements to allow for reasonable variations in transportation and accommodation costs.
- TWF may at its sole discretion change routes or withdraw places on the challenge event
- Should the event be cancelled due to government restrictions or any other reason, we will communicate this to you and explore options available.
- TWF may use photos of participants or correspondence for media purposes having sought express approval from participants.
